Higher Education Bursary Application Form

This bursary is available to; a current/past student who has graduated from F.P. Walshe School and who is a Canadian Citizen. It is intended to assist students with a proven scholastic ability, and who have a "demonstrated need" for financial assistance to facilitate attendance at a post-secondary institution in Canada. The bursary is awarded annually and is valued at two thousand dollars (\$2,000.00).

The award is made by a Committee of Alberta Lodge No. 3, whose decision is final. The decision will be based on financial need, academic standing, and local enquiries. Consultation with the staff at F.P. Walshe School may occur. Masonic connection is not a consideration. A request for a home visit may be made as part of the interview process. Interviews will be held in the month of May.

Applications must be filed with the Guidance Counsellor at F.P. Walshe School or with the Secretary-Treasurer Alberta Lodge No. 3, A.F. & A.M., PO Box 1825, Fort Macleod, AB, T0L 0Z0 no later than April 30th, to be considered for the following academic year. Applications must be accompanied by a current High School Transcript (Grade 11), and the most current record of marks (Grade 12). Where applicable, post-secondary transcripts must be submitted. Applicants who are advised their application is being held for further consideration will be responsible for providing a Certificate of Admission from the educational institution they will be attending. A cheque will be issued to the educational institution on behalf of successful applicant.
